Speed Study Requests

Manager Zeigler reported to Council that he sent a Letter to the York County Planning Commission requesting the following three (3) traffic studies be conducted: 1.) Spring Forge Drive (between Hamlet Drive West and Glenview Road); 2.) Glenview Road (between Monocacy Trail and Spring Forge Drive); 3.) Monocacy Trail (between Seneca Way and Hamlet Drive West).

Spring Grove Volunteer Firefighter's Relief Association – 1003 & 2004 Audit

Manager Zeigler presented to Council a copy of the audit report for the Spring Grove Volunteer Firefighter's Relief Association for the period covering January 1, 2003 to December 31, 2004 for their review. The audit was conducted by the PA Auditor General's Office.

Pending Litigation – David Lease (Hamilton Township)

Manager Zeigler reported that the Borough has been notified of possible litigation between (Plaintiff) David Lease (Hamilton Township) and the Borough's former Zoning/Codes Officer, Kevin Tyler (Defendant). Mr. Lease claims that Mr. Tyler, a Hamilton Township Supervisor and a Hamilton Township Police Officer conducted an illegal inspection on his property. The Borough's insurance company told the Borough that there is no need to be concerned at this time.

Roundabout Update

Engineer Knouse reported to Council that there hasn't been any activity on the roundabout since Council's last meeting. C.S. Davidson has been pursuing a price for the railing with Kinsley Construction, Inc. He will report back to Council when he learns more.

Sanitary Sewer Manhole Grade Adjustments

Engineer Knouse reported to Council that the third quote has been received for the sanitary sewer manhole grade adjustments. The lowest quote was received by Kinsley Construction, Inc. in the amount of \$9,731.00. Action was already taken at Council's last meeting to approve and award the lowest quote of the three received.
